#### Part A: Pupil premium strategy plan

#### Statement of intent

The needs of our pupil premium students at Churchill are varied and a one size fits all approach would not be appropriate. The strategy outlined encompasses a range of support we have developed in response to the needs identified here at the academy. We ultimately strive to reduce the achievement gap between pupil premium students and their peers through a holistic package of support led by high-quality teaching. This provision aims to reflect the varying needs including our more academically able pupils who are most at risk of under-performing. The support developed strives to engage our students in line with our curriculum vision and whole school teaching and learning principles.

We communicate openly with our families about the use of our funding and the support we can offer. We work closely with our families to ensure the funding reflects their individual needs. Families are consulted when accessing any of our pupil premium vouchers schemes.

#### Challenges

This details the key challenges to achievement that we have identified among our pupil premium pupils.

Challenge number	Detail of challenge
1	Literacy skills on entry to Year 7 are lower which slows progress across the curriculum and these remain lower in KS3 than required to successfully access higher level GCSE specifications
2	Historically some higher attaining pupil premium students have made less progress than other high attaining students. Also middle prior attainment pupil premium boys have made less progress than non-pupil premium students of similar prior attainment.
3	A higher proportion of pupil premium students experience social, emotional and mental health issues (SEMH), which can have a detrimental effect on behaviour and attendance.
4	Pupil premium students are typically disadvantaged with the provision of resources and equipment and/or lower participation in educational visits supporting the curriculum and this continues to impact on attainment and progress in some subject areas.
5	Many pupil premium students have a lack of support with learning at home and a lack of engagement of parents of

	pupils who are the most vulnerable to underachievement and this can result in low aspiration and lower achievement and progress
6	Many pupil premium students have significant welfare needs within the family impacting upon resources available with the home to support uniform, footwear, diet.
7	Support previously available to pupil premium families from Health and Social Care sectors has been withdrawn due to reduced funding and academy resources are insufficient to address this deficit.
8	Reinforcing staff awareness on the needs of pupil premium students.
9	Attendance for pupil premium students is lower than their peers.
